Dear Sir,

1.With reference to above subject, **Gayatri International School, A/p. Charholi, Tal. Haveli, Dist.Pune** is recognised CBSE school and having classes upto Class V and the school can not run the Class VI to X without Affiliation with the CBSE board.

2.The school has already applied for NOC from State Govt, but till it is not received and becomes delayed.

3.Last date of online application for CBSE Fresh affiliation up to secondary level is 30th June, 2025,


4. As per the CBSE amended Rule Clause 2.3.5 Amendment in Affiliation byelaws -2018, the school can apply for affiliation with or Without No Objection Certificate under following circumstances.

In case, the school applies for affiliation without NOC, then the board shall write to the concern State Government to obtain their comments, if any, on the application of the school for affiliation with the board. The Department may furnish its comments regarding the said application, if any, at the link provided in the letter within 30 days of issue of the said letter. In case no comments are received within the said period of 30 days, a reminder letter will be sent to the concerned State Education Department to raise their objection, if any, within another 15 days, failing which ,it shall be deemed that the State Government do not have any objection on the grant of affiliation to the school by the board and the application of the school will be considered for grant of affiliation, if it otherwise , fulfils the conditions for grant of affiliation as per the affiliation Bye-laws-2018 of the board. (Amendment of bye-laws 2018 copy is attached)

1. **Gayatri International School, A/p. Charholi, Tal. Haveli, Dist.Pune** is applying for fresh affiliation 2026-27 under amendment clause 2.3.5 of affiliation bye laws-2018.

Therefore, you are requested to raise comments to board, if any ,against said application as well as school too. Please acknowledge.
